

VISA APPLICATION FORM Terms & Conditions

1. Passenger/Guarantor is required to complete the flydubai Visa Application Form accurately and submit it with the applicable fee and specified documentation. Passenger must hold a valid passport (of at least 6 months) and comply with the flydubai Visa Application Form Terms and Conditions.

2. In the event that the Passenger does not leave the UAE by the visa expiry date, or is involved in any administrative, financial, medical, legal or other issue which adversely affects flydubai, all related fines, charges or costs at the minimum amount of Euro 1200 will be paid by Passenger/Guarantor

3. The decision of GDRFA-D on any Visa Application is final. In the event that a Visa Application is rejected, the Visa Application fee will not be refunded. No reason will be given and no follow-up correspondence will be entered into.

4. Issuance and approval of visas are solely regulated by GDRFA-D and governed by its rules and regulations, which are amended from time to time, subject to the Passenger fulfilling the eligibility criteria. The rules and regulations of the GDRFA-D are subject to change without notice.

5. All Passengers seeking flydubai's Visa Application services must hold a paid return booking with flydubai. flydubai shall not be held responsible or liable for Passengers which are unable to travel because of flydubai policy or any cause or circumstance beyond the control of flydubai.

6. The Passenger as bearer of a tourist, visit or transit visa is not allowed to work, paid or unpaid. If this clause is violated, the Passenger and/or Guarantor are solely responsible to pay any penalty charges and agree to indemnify flydubai against any liability which flydubai may incur as a result of such violation.

FORMULAR PENTRU VIZA E.A.U. Termene si conditii

1. Pasagerul / Garantul trebuie sa completeze formularul pentru solicitarea vizei de Dubai in totalitate si sa aplice pentru obtinerea vizei, dupa achitarea taxei aplicabile si transmiterea documentatiei solicitate. Pasagerul trebuie sa detina un pasaport valabil minim 6 luni de la data returului in tara si sa respecte termenele si conditiile specificate in cadrul formularului de viza.

2. In cazul in care pasagerul nu paraseste teritoriul E.A.U. pana la data expirarii vizei sau este implicat intr-o chestiune de ordin administrativ, financiar, medical, juridic sau de alta natura, care afecteaza in mod negativ flydubai, eventualele amenzi, taxe sau costuri, in valoare minima de 1200 euro, vor fi suportate direct de catre pasager sau garant.

3. Decizia biroului GDRFA-D referitoare la orice solicitare de viza este definitiva. In cazul in care solicitarea de viza este respinsa de catre autoritatile din Dubai, taxa aplicabila este nerambursabila. Nu se ofera nicio motivatie suplimentara si nici nu se va purta o corpondenta ulterioara pe aceasta tema.

4. Emiterea și aprobarea vizelor sunt reglementate exclusiv de biroul GDRFA-D, conform normelor și reglementarilor sale, ce pot fi modificate periodic, in functie de criteriile de eligibilitate indeplinite de pasageri. Normele și reglementarile biroului GDRFA-D pot fi modificate fara o notificare in prealabil.

5. Toti pasagerii care doresc sa aplice pentru obtinerea vizei E.A.U. prin flydubai trebuie sa detina o rezervare de zbor dus-intors cu flydubai, achitata integral. flydubai nu este responsabila pentru pasagerii aflati in imposibilitatea de a calatori din cauza politicii flydubai sau din orice alta cauza ce este in afara controlului flydubai.

6. Pasagerii care au obtinut o viza pentru E.A.U, turistica , de vizita sau de tranzit, nu au permisiunea de a desfasura o activitate lucrativa pe teritoriul E.A.U, remunerata sau nu.
